EDI R3.1 Recent Updates

Claims EDI R3.1 Recent Updates

- An update to DN0059 (Manual Classification Code) with the current New York Compensation Insurance Rating Board (NYCIRB) codes was posted to the Board's website on 4/18/2022.
- The April webinar recording and slide deck is now available on the eClaims Presentation page.
- A clerical edit to DN0154 (Employee ID Assigned by Jurisdiction) was implemented on 4/29/2022, updating element error text on DN0154-117.
 - Was: cannot be changed; send EE's SSN when available.
 - Now: must be NYS WCB format; send EE's SSN if available.
 - Business Need: Changed logic of DN0154-117 to now accommodate for Employee Date of Birth change when accepting DN0154.
 - eClaims trading partners have been provided with a list of cases in which an invalid format was submitted and a FROI-02 should be submitted to correct the error.

Claims EDI R3.1 Recent Updates

- In DN0036 (Part of Body Injured Code), the Population Restriction - DN0036-065 B) was relaxed on 5/19/22. Claim administrators can now submit Multiple Head or Multiple Neck codes without needing 10 Parts of Body codes in the transaction.
- Other relaxed edits are being developed and will be published on the next NYS eClaims EDI R3.1 Change Log.

Most Frequent Error in EDI R3.1



DN0075-064K Population Restriction

- Results of an Error Report run by the eClaims leadership team indicate that the following is the most common error returned to most claim administrators to date in R3.1:

DN	Report or MTC	Data Element Name	Population Restriction
0075	SROI-02	Agreement to Compensate Code	<p>K) Agreement to Compensate Code can be the same as previously reported only when denial is in effect. If Denial is still in effect</p> <p>and DN0075 (Agreement to Compensate Code) is included in the Change Variable segment and has the same value as last reported then the assumption is that the claim is being accepted on this SROI.</p> <p>Note: Denial is still in effect, until the claim is accepted as stated in FAQ: (1) To accept a claim after your accepted FROI-04, for cases with a date of accident prior to 1/1/2019, you need to submit a FROI-00 with Claim Type Code other than N (Notification of an Incident Only). If you try to file a FROI-00 with N after your FROI-04, it will be rejected. For cases with a date of accident on or after 1/1/2019, you need to submit a FROI-00 with Agreement to Compensate Code of L (With Liability). If you try to file a FROI-00 with W (Without Liability) after your FROI-04, it will be rejected. (2) To accept a claim after your SROI-04, you need to submit a SROI that indicates what event has occurred that shows acceptance or a SROI-02. If sending a SROI-02, for cases with a date of accident prior to 1/1/2019, you will need to send Denial Rescission Date (DN0196). For cases with a date of accident on or after 1/1/2019, the Agreement to Compensate Code shows acceptance of a claim.</p>

DN0075-064K Population Restriction, cont'd

- DN0075 (Agreement to Compensate Code) should not be included in the Change Variable Segment on SROI-02 if it is the same value as previously reported unless you are now trying to indicate that you are accepting a medical-only claim after a denial.

EXAMPLE:

DO:

- FROI-00 with Agreement to Compensate Code = L (With Liability)
- SROI-04 with Agreement to Compensate Code = null (blank)
- SROI-02 to accept claim after a denial on medical-only claim. Agreement to Compensate Code = L and included in change variable segment.

DON'T:

- FROI-00 with Agreement to Compensate Code = L
- SROI-IP with Agreement to Compensate Code = L
- SROI-SA with Agreement to Compensate = Null (blank)
- SROI-02 with Agreement to Compensate = L in the change variable segment as A-Add

Reminder: New Edits Effective 9/15/2022

- The following new edits were posted on the NYS eClaims EDI R3.1 Change Log on 3/15/2022 with six months' notice provided, in accordance with the IAIABC Claims EDI standard.

Item #	Document	Item	Description of Change	Publish Date	Implementation date
304	Edit Matrix - Population Restrictions	DN0041 (Date Claim Administrator Had Knowledge of Injury)	Modified Edit. Currently 0041-064 B) compares DN0119 (Accident Site Narrative) to DN0164 (Employer Physical Country Code) when determining whether DN0123 (Accident Site State Code) is required. It is being updated so that DN0119 is instead being compared to DN0280 (Accident Site Country Code). Business Need: This was a typo in the Population Restriction that we are correcting.	3/15/2022	9/15/2022
311	Edit Matrix - Population Restrictions	DN0085 (Benefit Type Code)	Clerical Edit. Renumbered '0085-064 C)' to '0085-064 B)', '0085-064 D)' to '0085-064 C'. Business Need: The other Population Restrictions for DN0085-064 need to be removed to accommodate the removal of 0085-064 B).	3/15/2022	9/15/2022
312	Edit Matrix - Population Restrictions	DN0192 (Benefit Payment Issue Date)	Modified Edit. 0192-064) was modified removing the condition that evaluated whether the incoming value for DN0192 was before any previously accepted value for DN0192. Was: If the earliest DN0192 (Benefit Payment Issue Date) reported on the SROIs accepted on that case is more than 365 days in the past then DN0075 (Agreement to Compensate Code) must be L (with liability). If DN0075 (Agreement to Compensate Code) is not L (with liability) and DN0192 (Benefit Payment Issue Date) is before any other accepted DN0192 (Benefit Payment Issue Date) and is more the 365 days in the past or ANCR/ODNCR has been established, then DN0075 (Agreement to Compensate Code) must be included in the Change Variable Segment. Now: If the earliest DN0192 (Benefit Payment Issue Date) reported on the SROIs accepted on that case is more than 365 days in the past, then DN0075 (Agreement to Compensate Code) must be L (with liability). If DN0075 (Agreement to Compensate Code) is not L (with liability) and DN0192 (Benefit Payment Issue Date) is more than 365 days in the past or ANCR/ODNCR has been established, then DN0075 (Agreement to Compensate Code) must be included in the Change Variable Segment. Business Need: This is to prevent DN0075 from being "W" if the Benefit Payment Issue date is now greater than 365 days in the past.	3/15/2022	9/15/2022
